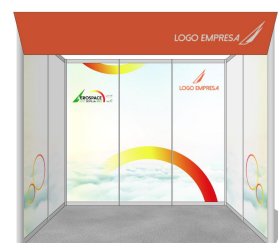

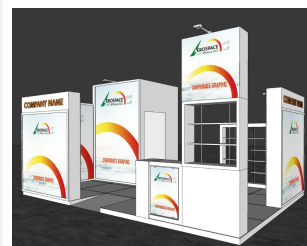

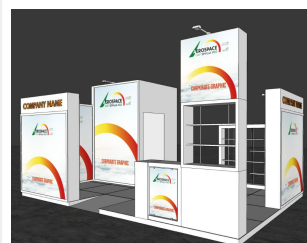

1/ ORGANIZATION

This agreement is organized by **abe - advanced business events**, a limited company with a stated capital of 50000 Euros, whose registered head office is located at 10 RUE DE LA ROCHEFOUCAULD CS 50300 92100 Boulogne Billancourt Cedex – France, hereafter referred to as the Organizer.

2/ PURPOSE

This agreement stipulates the terms and conditions, under which the Organizer sets up and runs the Event. This agreement highlights the rights and obligations of both the Organizer and the signing company, hereafter referred to as the Participant. 3/ PLACE AND DATE
